FEES: Our fee for each session includes all living expenses, instruction, facilities, and equipment in all activities, laundry of all personal clothing and linens, in addition to the services of the camp health center including our camp physician.

There is no fee reduction for campers arriving late or leaving early.

In the unlikely event of an accident or illness requiring a trip to one of our local physicians or specialists, or the need for a prescription while at camp, our nurses will call you for credit card information to pay for health care services. We will forward all necessary paperwork so that you can submit the claim to your insurance for reimbursement.

SHEETS, BLANKETS, TOWELS AND WASHCLOTHS WILL BE FURNISHED TO ALL CAMPERS. PLEASE BRING YOUR OWN PILLOW AND PILLOW CASES.

We reserve the right to refuse acceptance to any applicant, who in our judgment, will neither benefit from nor contribute to the camp experience. We also reserve the right to dismiss from camp a girl who in our judgment, is detrimental to the camp community.

SHIP'S STORE: Campers at the August and Mini sessions should have \$75.00, June session \$85.00, and July session \$100.00 deposited to their Ship's Store account for incidental camp purchases, due with the final balance. The unused portion is refunded after the session ends.

REGISTRATION AND PAYMENT TERMS:

Applications are accepted for a full session only. All applications must be filled out completely and mailed with a deposit of \$750.00 to: **Camp Illahee, 500 Illahee Road, Brevard, NC 28712-9154.** Our sessions fill early, and we do recommend using an overnight courier.

The second payment of half the balance is due February 1, 2012 and the remaining balance on or before April 1, 2012. Please make checks payable to Camp Illahee. If a cancellation is necessary, the deposit, less a \$100 processing fee, is refundable if written notice is received prior to February 1.

The deposit is non-refundable for cancellations after February 1, 2012. There is no refund made for cancellations after May 1, 2012. The \$750.00 deposit of an applicant on the waiting list is fully refundable if space does not become available.

VISITATION

Attending camp provides a unique opportunity for campers to gain the self-reliance, self-confidence, and independence important to a young girl's development; therefore the camp program should not be interrupted with visits by parents, relatives, and friends. We highly recommend parents visit camp on opening and closing days of the camp session. At this time, parents are encouraged to meet the staff and view the camp facility.

NO PACKAGES PLEASE

In an effort to create a non-materialistic and non-competitive community, Camp Illahee has a **no package policy**. Care packages mailed to campers will be returned to the sender. Please notify family and friends to avoid disappointment on the part of both the sender and recipient.

WEBSITE AND EMAIL

Most of our parent communication occurs through email, so it is important for us to be made aware of any changes. Our website (www.campillahee.com) provides the most up-to-date information regarding camp. During the summer, Gordon Strayhorn, one of the directors, will post a nightly update with pictures of your camper from the day. This has proven to be a great way for moms and dads not to become too "parentsick" while their camper is enjoying camp. There is also a link so that you can email your camper. We print emails out daily and deliver them to your camper. Of course, "snail mail" is also encouraged. Campers do not have access to computers to return emails.

TRAVEL SUGGESTIONS

Girls may travel to camp by airplane or automobile. Campers arriving by plane will be met on opening day and transported on closing day to the Asheville, NC airport or the Greenville, SC airport at no charge. Please make your airline reservations as soon as possible for opening and closing days and be sure to ask about unaccompanied minor policies for all campers under age 15. Campers are involved in activities after lunch on opening day so **PLEASE SCHEDULE ARRIVALS BETWEEN 10:00 AM AND 12:00 NOON AND DEPARTURES BETWEEN 9:00 AM and 11:00 AM**. If your daughter is flying to camp, she will need a small carry-on bag with a change of clothes, tennis shoes, and a bathing suit.

We accept applications in the order in which we receive them. Should we receive your application after we have reached our capacity, we will notify you that your name has been placed on our waiting list.

*Indicates articles recommended which may be ordered through camp. Detailed information for online ordering will be sent in the spring. *Campers need only one white uniform*. Campers are fitted for ordered uniforms and other apparel on the afternoon they arrive at camp. Each girl should bring enough clothes to carry her through one full week of camp.

Optional accessories are digital camera, Bible, musical instrument, favorite art materials, dress-up costumes, books, and needlecraft materials. Campers who plan to participate in tennis should bring their own racquets.

Please label all articles with camper's name. A list of all articles brought to camp should be posted in the top of each trunk. *Camp staff cannot be responsible for camper clothing and other equipment*. Campers should not bring jewelry, money, or non-essential articles of value. **Radios, TV's, handheld games, video Ipods, WiFi enabled devices and cell phones are not permitted**. Hair dryers are permitted in designated areas.

LONG PANTS, HARD-SOLED SHOES WITH HEELS OR BOOTS, AND HARD HATS ARE REQUIRED FOR ALL RIDERS. Illahee will provide helmets and boots for campers who do not bring their own.

No luggage larger than a trunk (one only) may be brought to camp. We strongly suggest soft-side trunks or duffel bags. Luggage may be brought in the car with the camper, checked on an airline ticket or sent via United Parcel Service or FEDEX (preferable) prior to camp. **OUR MAILING AND SHIPPING ADDRESS IS 500 ILLAHEE ROAD, BREVARD, NC 28712.**

I hereby give permission to the physician selected by the Camp Director to hospitalize and/or treat my child and agree that I will be financially responsible for any charges for services provided by medical professionals for any accident, injury, or illness incurred while enrolled at Camp Illahee. Further, I understand that it is Camp Illahee’s policy that any camper who arrives at camp with a fever or other signs of illness cannot be admitted into the camp community until the medically accepted “quarantine” period has expired. In the event that this occurs, no refund of camp fees can be made. Cancellation insurance is available from third-party providers and referrals can be provided upon request.

I understand it is the responsibility of parents/guardians to become familiar with all of the activities and programs offered by Camp Illahee as described in the website, literature, videos, and in the parent handbook. I understand that my child’s participation in Camp Illahee and any activity is completely voluntary. I further recognize that there are hazards and dangers inherent in camp events and programs, and although Illahee has taken measures to minimize the risk of injury to camp participants, it cannot guarantee that the participants, equipment, premises and/or activities will be free of hazards, accidents and/or injuries. I further recognize and have instructed my child in the importance of knowing and abiding by the camp’s rules, regulations, and procedures for the safety of camp participants.

I agree that any dispute between Camp Illahee, its owners, officers, directors, employees, contractors, volunteers and me shall be governed by the substantive laws of the State of North Carolina, and that any mediation or suit initiated for me and/or on behalf of my minor child named above shall occur or be filed in Transylvania County, North Carolina.
